CALL TO ORDER:

Deputy County Attorney, Andrea Fraser called the meeting to order at 5:03 p.m.

PUBLIC COMMENT:

REVIEW OF FLORIDA “SUNSHINE LAWS”:

Assistant County Attorney, Joe Adams provided an overview of the following:

- [Florida “Sunshine Laws”](#): The Florida “Sunshine Law” covers all forms of communications such as spoken words, emails, messages, etc., on matters that come before this Commission for official action.
- [Florida “Public Records Law”](#): The Florida “Public Records Law” is found in Chapter 119 of the Florida Statutes. The Florida “Public Records Law” states all documents in possession of the government are held in public trust for the people in the State of Florida.

ELECTION OF CHAIR, AND VICE CHAIR:

Deputy County Attorney, Andrea Fraser opened the floor for Chairman Nominations. Maryanne Preston nominated Nathan Shaw, seconded by Kevin Besserer. Mr. Shaw was unanimously elected Chairman with Ismael Hernandez absent.

At the request of the Chairman, Ms. Fraser opened the floor for Vice-Chairman Nominations. Andrew Sund nominated himself, seconded by Ronald Inge. Mr. Sund was unanimously elected Vice-Chairman with Ismael Hernandez absent.

INITIAL DISCUSSIONS CONCERNING THE LEE COUNTY CHARTER:

Deputy County Attorney, Andrea Fraser provided the Commission with a brief history of the Lee County Charter. Ms. Fraser informed the Commission that a Charter item securing a three-fifths (3/5) vote will be forwarded to the Lee County Board of County Commissioners for approval or denial. Furthermore, any item securing a four-fifths (4/5) vote will be moved directly to the ballot for voting. Ms. Fraser concluded her short [presentation](#) with a [review](#) of the differences between Charter and Non-Charter Governments.
